## Flu shots help keep employees protected and productive.

Each flu season, nearly 111 million workdays are lost due to the flu. That equals approximately \$7 billion per year in sick days and lost productivity.<sup>1</sup> A vaccine is the best defense against the flu—and getting a shot can help protect the people around you.

The Centers for Disease Control and Prevention (CDC) recommends annual flu vaccination for everyone 6 months and older. Encourage your employees to protect themselves and others by getting a flu vaccine.<sup>2</sup>

## Convenient provider access makes getting flu shots quick and easy.

UnitedHealthcare contracts with a variety of national pharmacy chains and retail convenience care clinics to offer members easy access to flu vaccines.

Annual flu shots are covered at \$0 out of pocket when members use one of the following network providers. Members should bring their health plan ID card and tell their provider the flu shot is covered under their benefits.
